Race 2; 5 Runners; No Driver Changes
No. 1 Tigress stopped at the gate and would not come forward, a false start was called. The stewards have decided that this horse will be placed on the outside going forward.

The driver of No.3, Mr. M O'Reilly lodged a complaint after the race with the stewards in relation to close driving, on the final lap of the race. On reviewing this race, and interviewing the driver of No.4, Meadowbranch Romance, Mr. D Mc Carthy no interference took place but in fact Mr O’Reilly's horse slipped causing him to break stride.

The driver of No.1, Mr. R Phelan was cautioned for not keeping a straight line coming to the finish. In addition, Mr R. Phelan was 6 strikes over the threshold in the last 500 m under the new whip rules and was fined $€ 50$ plus one demerit point.

Race 1; 6 runners; 1 driving change Alan Richardson drove No. 1 Ha Penny Chance The same horse was placed last after a break and went over the limit No other issues reported in this race.

Race 2; 8 entries; 2 non-runners No. 1 Oakwood Amari \& No. 7 Panama's Girl No. 6 Caenwood Tribute pulled up after breaking front hopple as a result of driving into the back of Horse No. 8 IB Paddington.
No other issues reported in this race

Race 3; 9 runners; 1 driving change Lee Kelly drove No. 8 Boyardo
No. 1 Go Away and No. 2 Geribia de Laval both places behind field after breaking and going over the limit.
No other issues reported in this race.

Race 4; 6 runners; No driving changes
The driver of No. 2 Newtown Major, Mr. T. McAleer exceeded the 2021 whip rule by 15 strikes in the last 200m and included shoulder action. Mr. T McAleer received a fine of $€ 200$, a 2 day driving ban \& 2 demerit points.

An incident occurred on the back straight just after the $3 / 4$ mark when it seemed W.S went on the grass coming to the bend , after viewing the video it would appear that Mr. Stewart Jnr had a clear run up the inside of the of the other horses and Mr. N Ryan came in pushing Mr. Stewart Jnr onto the grass. Due to personal circumstances surrounding Mr. N Ryan on the day of the race the stewards thought that it would be inappropriate to interview him at this time and will speak to him at a later date. No other issues reported in this race.

Race 7; 9 runners; 1 driving change Mr. S McHugh drove No. 2 Mooreside Captain
The stewards wish to speak to the driver of No.3, Ms L McNevin following ahead of racing in Portmarnock next week, as a result of close driving at the start of the race.

Race 8; 4 runners; No driving changes
There was a handicap change in this race on the day and No. 4 Biniou Du Beuvron was pulled to a 40 yard trail from his original mark 4 on the gate

Following an objection to the official result called at race day, the stewards reviewed the race result under rule H28. As a result of this review, No. 1. Dusty Jiel was also disqualified and exceeded the strides allowed in the race.
