Race 6: All 6 Ran, One driver change, Troy McAleer drove Northern Pride. No other issues.

Race 7: All 5 Ran. One driver change, Oisin Quill drove Destin De Larre.

Following an incident in a coming together of their carts by the entrance to the track, Drivers Donal Murphy and Patrick Hill were interviewed. Having considered their evidence, In the opinion of the Stewards, Donal Murphy was in breach of Rule M4(j), drove in a

careless or reckless manner and was fined €50 plus a two day suspension. No other issues.

Race 8: All 6 Ran.One driver change, Troy McAleer drove Newtown Major.

Following an incident going into the final bend wher it appeared that Showtime Notorious received a check. The Stewards interviewed Drivers John Boyle and Derry McCarthy. Having considered their evidence, In the opinion of the Stewards John Boyle failed to allow sufficient room to the horse on his inside causing a collision and was in breach of Rule M4(j), drove in a careless or reckless manner. He was fined €50 plus a two day suspension.

Race 9: All 5 Ran. Seamus Quill was interviewed by the Stewards and was found to be in breach of Rule M6, unduly looking around during the race and was fined €50. Oisin Quill was also interviewed following this race. Both drivers were cautioned in relation to team driving and to their future conduct.

Jamie Hurley was interviewed by the Stewards following an incident during this race. He was found to be in breach of Rule M4(c),failure to give proper clearance when pulling in front of another horse and was fined €50.

Race 5: All 4 Ran.

Patrick Hill and Seamus Quill were in breach of Rule M5, shouting during the race and were each fined €50.

Race 6: All 6 Ran. Two driver changes, Anthony McCarthy drove Teddy Camden and Troy McAleer drove Newtown Major.

Race 7: All 6 Ran. Two driver changes, Seamus Quill drove Beach De Bellouet and Finbarr Quill jnr drove Cakinap.

There was a Stewards Enquiry into the horse first past the post to ascertain that he hadn't exceeded the maximum strides in a gallop during the race. The decision of the enquiry was to allow the result to stand.

Oisin Quill was in breach of Rule M5, shouting during the race and was fined €50
